Where We've Been—Where We're Going

Letter from the Executive Director

IN THE MIDST OF continued economic challenges, Urban Ministries of Durham remained committed to its mission to provide food, clothing, shelter, and supportive services to our neighbors in need. And while our mission hasn't changed, the manner in which we approach and achieve it has. We have taken a strategic, focused, results-driven, yet compassionate approach to adapt to this new normal.

You will read about some of the notable financial accomplishments in the letter from the Treasurer. Here I will highlight some of the key programmatic changes that we made, along with successes achieved, while meeting increased demand without compromising the quality of care.



We continue the cultural shift from UMD “the destination” to UMD “a point along the journey” where we help people move forward.

Strategic & Focused Approach

I. Homelessness Prevention Groceries, Clothing, Meals, Prevention Screenings, Referrals	Shift from measuring services provided TO measuring desired outcomes

Key focus areas include:

I. Homelessness Prevention

Over the past year, we provided more groceries, clothing, and meals than ever before from the Food Pantry, Clothing Closet, and Café. Receiving these services allows people to use their income for housing and other expenses. At the height of demand, grocery and clothing distributions increased 150% over the previous five years. In response, we expanded prevention services, such as on-site food stamp registration, disability enrollments, screenings to measure risk of homelessness, and referrals to appropriate community support services within the continuum of care. UMD aims to build upon these efforts in the coming year. We will become a NC Benefit Bank host site and enlist the support of partner agencies to further increase on-site services for those at risk.

II. Homeless Re-Housing

In addition to providing a safe and clean place to sleep, three nutritious meals a day, and access to the Food Pantry and Clothing Closet, UMD launched the Journey Program. This program provides more case management and connections to resources to help move people from the shelter to transitional and permanent housing.

Between January 1, 2010 and June 30, 2010, with one full-time case manager, we are pleased to report that a total of 71 individuals moved successfully from the shelter:

- 56 to permanent living situations.
- 15 to transitional housing.

Building upon these initial successes, UMD was awarded a grant from the NC Sisters of Mercy Foundation to add two full-time case managers. Additional resources dedicated to the Journey Program in the coming year include 13 interns from local universities and one AmeriCorps volunteer. The goal by June 30, 2011 is to enroll 400 of those seeking emergency shelter in the Journey Program and to re-house 200 of them in permanent and transitional housing, with an average length of stay of 90 days or fewer in the shelter.

III. Emergency Assistance and Compassionate Care

UMD continued to provide emergency assistance and compassionate care for the chronically homeless, while promoting options for lifestyle change. The reality is that some people are not yet at the point in their journey to

The Stewardship Journey

A Message from Susan Freya Olive, Board Treasurer

UMD has been blessed with wonderful donors and granting agencies during the past fiscal year. Our internal and professional audits confirmed that the previous fiscal year had left the program with a deficit balance of \$267,513. Despite the daunting size of that deficit, UMD rose to the challenge and, for our fiscal year that ended June 30, 2010, showed a bottom-line balance of \$6,807.

How did we do it? First, we brought our bookkeeping operations in-house so that we could eliminate reporting delays. Second, we upgraded our financial reporting both in detail and in frequency, and we made good use of the financial and business acumen of board members on our finance committee to oversee that reporting. Third, we hired a business manager with high-level business as well as accounting experience—Gregg Lasseter, former VP of Finance of the Biltmore Company. Fourth, we enlisted the help of the entire staff, not only in conceiving and carrying out UMD's cost-cutting measures, but also in strategizing sources of income and in planning our budget. Finally, we increased both our cash and our in-kind revenues.

The increased revenues cannot be over-emphasized. We are abundantly grateful to those who have contributed to our journey from a critical fiscal position only 12 months ago, to the much more secure base we will build upon going forward. We invite you to review our audited financial statements and our information returns on our website, as well as the summaries of key financial data that are included in this Annual Report, and to celebrate with us the successes we achieved last year.

As we turn our attention to the current fiscal year, we cannot rest on our laurels, as we expect to face even greater demands down the road. While recognizing that some of the poor will indeed always be with us, we have committed to an aggressive program aligned with the goals of the Ten Year Plan to End Homelessness. That program requires more resources, and thus more dollars, than does a program that feeds, clothes, and shelters those in need without providing supportive services.

Our budget for the current fiscal year reflects those added costs and requires that we raise \$302,900 in cash and in-kind contributions over and above our income for the prior year. We have found during the past year that our community is full of those who understand and live by Winston Churchill's principle: “We make a living by what we get; we make a life by what we give.” We are confident that, with your help, UMD can continue the journey and meet the goal.

make a change, but the most basic needs of food, clothing, and shelter must be met in order for people to hope for and envision a better future. Sharing an environment with their peers that are making progress in their journeys provides added encouragement for change. Regardless of where someone is in his or her journey, UMD provides access to information on additional community resources as well.

IV. Collaboration with Continuum of Care Partners

Collaboration with partners in the continuum of care was and remains a priority. In October 2009, UMD's Board of Directors recommitted the agency to serving as an entry point in the community's continuum of care. The Board adopted strategies that assume UMD best serves when it is assessing the needs of those who are homeless and at risk

and helping them to make the connections that will enable them to take the next steps in their journeys. Our goal was to bring services to the point of need:

- Housing for New Hope offices were established on-site.
- Durham Center conducts on-site mental health assessments and bi-weekly CARE team reviews.

In the coming year, UMD intends to bring additional partners on-site. We are evaluating the feasibility of hosting a Day Service Center for those who are homeless and at risk.

The past year has been one of vision and transition. Now the journey continues as we further implement these new plans.

The Year in Review: 2009–2010 Annual Report

Program Highlights

COMMUNITY SHELTER

- Provided 52,291 nights of emergency shelter to 1,248 individual guests—a 12% increase over last year. Though we served fewer unduplicated individuals this year than last year, clients stayed with us longer; they needed more assistance transitioning to permanent and transitional housing, as a result of unemployment and lack of affordable housing.
- Served 58 families, including 112 children.
- Provided case management services to 211 unduplicated individuals participating in the Journey Program.
- Placed 15 individuals in transitional housing.
- Placed 56 individuals in permanent housing.
- Referred 52 individuals to Housing For New Hope for re-housing.
- Established 230 connections with other services supporting long-term stability.
- Graduated 24 adults from the Journey Hope-Believe Recovery Program.

COMMUNITY CAFE

- Served 219,552 meals to 5,791 unduplicated guests, an 11% increase from the previous year.

FOOD PANTRY

- Distributed 67,917 pounds of food, a 50% increase over last year.

CLOTHING CLOSET

- Distributed 47,964 articles of clothing, a 50% increase over last year.

Fund-Raising & Special Events

- Annual Empty Bowls benefit set another record, raising \$28,000 for the Community Café.
- Annual Rebuilding Lives Breakfast raised over \$70,000 in gifts and pledges.
- UMD exceeded the \$25,000 Stewards Fund Challenge in new and increased gifts from February 1–May 31, 2010.

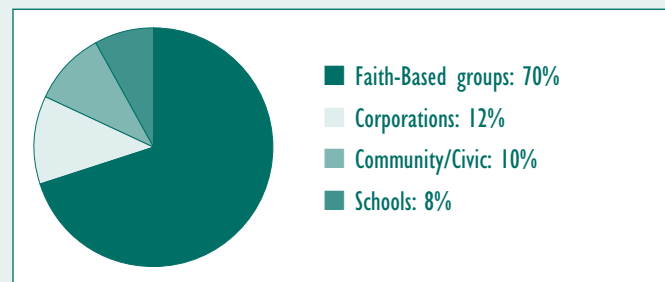
Volunteerism

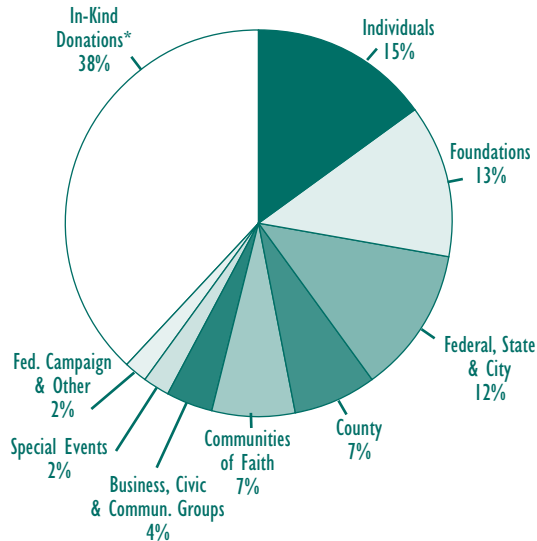

UMD's audited financial statements for the 2009–2010 fiscal year show that 88 cents of every dollar donated directly supports our program services.

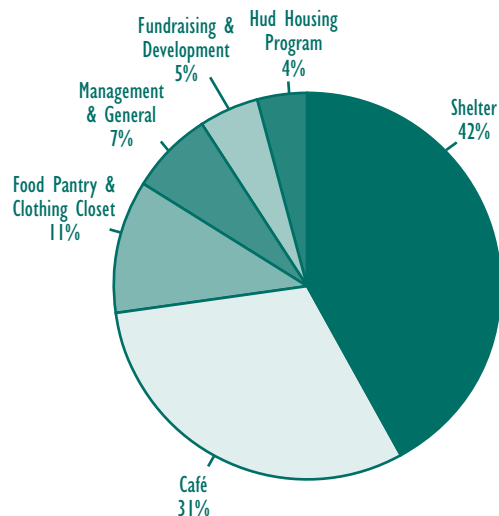
Revenues by Source
