Community shelter: Offers emergency shelter for 149 men, women and children per night, plus 30 additional spaces for adults when weather conditions are dire. In fiscal year 2018-2019, 686 unique individuals were served in this manner, accounting for 48,047 nights of shelter. The shelter team (Case Management/Work Development/Shelter Management) collaborated with 248 individuals to help move out of the shelter and into permanent housing.

4b (Code:) (Expenses \$ 921,736. including grants of \$) (Revenue \$)

Community Cafe: Provides three meals per day, 365 days per year. In fiscal 2018-2019, Urban Ministries of Durham served a total of 228,406 meals to those facing food insecurity. In addition to our standard full breakfast and dinners and brown bag lunches, meals this year included late dinner plates and early breakfast bags to accommodate client work schedules.

Food Pantry and Clothing closet: Supplies groceries and needed clothing to approximately 500 households per month. In fiscal year 2018-2019, 141,689 lbs. of food and 39,299 articles of clothing were distributed. Operations this year included a full year of expanded hours to serve the working poor.
